

# The Program

Supporting Children after Separation (*Supporting Children*) program offers help and support to children whose parents are separating or divorcing.

The program offers a range of services to help children to understand and manage the changes in their family relationships, both during and after the separation of their parents.

## Services

Children from separated families will gain support and assistance to deal with the issues arising from the breakdown of their family through:

### Counselling

Children and adolescents will have the opportunity to attend individual counselling sessions where they can express their thoughts and feelings about their parents' separation through a range of avenues including play therapy, story telling, art and drama.

### Group work for primary and secondary aged children

The program offers group work programs to children and adolescents. The group work helps children to understand they are not alone after their parents have separated and addresses issues such as coping with ongoing parental conflict and moving between homes. The groups also provide an opportunity for peer support and understanding.

### School based skills education programs

Primary and secondary schools can access education and skills training to assist children in building and maintaining healthy relationships, developing communication and conflict resolution skills, dealing with grief and loss and caring for themselves in the midst of parental conflict

### Child Inclusive Practice

Children whose parents are going through Family Dispute Resolution process will be provided with an opportunity to discuss with a child counsellor how their parent's separation is affecting them, so the parent's can have a better understanding of their children's support and parenting needs.

### Integration Programs

The Supporting Children Program will be able to assist families by linking them to other programs offered by the Family Mediation Centre including:

- Family dispute resolution
- Post separation parenting program
- Parent and adolescent mediation
- Men and Family Relationship Program
- Financial counselling
